

PRIVACY POLICY – BOSTON UNISOFT TECHNOLOGIES.

Boston Unisoft Technologies. (“BOSTON UNISOFT TECHNOLOGIES”) believes that the privacy and security of an individual’s personal financial information is important. BOSTON UNISOFT TECHNOLOGIES is committed to its privacy obligations under applicable law and regulation. This privacy policy describes how we handle and protect personal information we collect about individuals who apply for or receive our products and services. INFORMATION COLLECTION

INFORMATION DISCLOSURE
